- 4. Cribbs on the Cobb building
 - a. Nate asked Darin Haslip about state codes and homes that are habitable
 - b. Since this building has no gas and no water, it is not habitable
 - c. Darin recommends that nobody lives there
 - d. Mayor Peirce stated that the city has resolutions and ordinances and it is our job to enforce them
 - e. The rental ordinance is very clear on what needs to be done to enforce it
 - f. Darin needs direction from the city on what to do
 - g. Laura will draft up a letter stating the ordinance they are in violation of and send it certified in the mail

5. RS Fiber Update

October 14, 2024

- a. All the cities agreed with our stance that they need more information before they can make a decision on selling RS Fiber
- b. The cities are discussing getting an attorney to discuss the issue with RS Fiber
- c. They are trying to find out what RS Fiber's assets and debts are before the cities make a vote
- d. RS Fiber has called an emergency meeting, so they are waiting to see what they have to say
- 6. Camper parking/storage
 - a. Council member Eitel called the sheriff about a camper that was parked on the street and they told him that we have no ordinances on it
 - b. Mayor Peirce suggested Council member Eitel find out which officer it was that said we have no ordinance, then we can print off the ordinance and send it to the officers
 - c. Mayor Peirce said that based on our ordinance, as long as they move their camper every 72 hours, they still do not violate our ordinance
- 7. Water/sewer added to the building by Cactus Jacks on South Street
 - a. John Neisen wants to connect water to his building just west of Cactus Jacks, next to the elevator
 - b. Mayor Peirce brought up the questions that the council had when this was first brought up
 - i. What will he do with the sewer water run off
 - c. Mayor Peirce stated that outside of his building, there will need to be 2 separate troughs
 - d. Cactus Jacks is ok with him connecting to their sewer line
 - e. To keep costs down, John Neisen would like to do the sewer work (30-40 feet of pipe), but for water, he will have a contractor do the work

Motion to approve John Neisen hooking up water and sewer to his building west of Cactus Jacks on South Street, Eitel/Broucek, all in favor, motion carries

- 8. R&R excavating
 - a. R&R Excavating is asking where we are at on funding and the outlook of our project
 - b. They have an excavator being transported back. After maintenance is done, if we are planning to move forward, they would like to store it here to be ready to go in the Spring
 - c. Mayor Peirce stated that we are 13th on the list to receive funding
 - d. Last year the bonding bill didn't pass, so the state ran out of money
 - e. As of right now, things are at a complete standstill because of where we stand in the lineup for receiving money
